the witness, having been duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

- Q Sir, tell the Jury your name, please?
- A. James Shipman.
- Q. You are the father of Jim and Joey Shipman?
- A. Yes.
- Q. You are living in Piqua now, right?
- A. Right.
- Q What do you do there? Where do you work?
- A. I run a service station.
- Q Back in February of this year, where were you living?
- A. Moraine.
- Q Where were you living in Moraine, do you remember?
- A. In the trailer park.
- Q Do you recall the address of your trailer?
- A Cozy Lane.
- Q. Do you remember if your trailer had any particular name on it?
 - A. Fairmont.
- Q Back in February, the first part of February, where were you working?

- A. The first part of February?
- Q Yes.
- A. Piqua.
- Q You had just taken over managing that station?
- A The 31st of January.
- Q So, you commuted from Moraine City up to Piqua each day?
 - A. Right.
 - Q Was your wife working at that time?
 - A. Right.
 - Q Where was she working?
 - A. She was working with me for the first week.
 - Q Okay.
- A. For the first week. Then, after that, she took the station in Sidney, a Sohio Station.
 - Q. She is managing a gas station now?
 - A. In Sidney, yes.
 - Q. You both manage Sohio Stations?
 - A. Right.
 - Q When did you move to Piqua, do you remember?
- A. We drove it two or three weeks. I wrecked my car on the ice. I don't recall exactly when, but it was -- I am sure it was in February. I am pretty sure.
- Q Mr. Shipman, do you remember the day that David Rowell's body was found out there in that field?

- A. I think it was on a Saturday.
- Let me take you back to the day, or night before actually, Friday. Did you work that day?
 - A. Yes.
 - Q. This was up at the Sohio Station in Piqua?
 - A. Yes.
 - Q About what time did you get home, do you recall?
 - A. It was between 7:00 and 7:30, I think.
 - Q Were your boys at home when you got home?
- A. No, they weren't home. We was going to take them to the Civic Center for a movie. They left a note they was going, so when it was over, we started looking for them.
- Q Did you have the occasion to go to the Civic Center looking for them that night?
 - A Yes. We drove over after the movie was over.
 - About what time was that, do you remember?
- A. I don't know. They was closing up. It was after -I guess it was around 9:00 or 9:30, I guess.
 - Q. Did you see them there?
 - A. No.
 - Q. What did you do after that?
- A. We drove around through the trailer park a couple times and went back to the trailer to see if they were home. We left and went back to -- went up to the Save Mart. We got a phone call from the Sidney station. We had the only keys to lock up the

station because she hadn't given anybody any keys. We had to drive back up to there to lock up.

- Q You stopped by the Save Mart before you drove back to lock up the store?
- A Yes. I had to get gas, and we had a friend call to check on the boys.
 - Q. What was the friend's name?
 - A. Pardon?
 - Q. What was the friend's name?
 - A Ellen Purvis or something like that.
 - Q A friend of your wife's?
 - A. Yes.
 - Q Ellen Purvis?
 - A Yes. Someone my wife used to work with.
 - What time did you get home from Piqua the second time?
- A. We drove straight up there and back. We was probably gone two or two and a half hours, I guess. We drove to Sidney and back, stopped and got a sandwich on the way back, which took about twenty minutes, I guess. Probably two or two and a half hours from the time we left.
 - Q That would put the time about when, estimating?
- A. Oh, it was somewhere around 10:00, I guess, or so when we left; 10:00 or 10:30, I guess when we left Save Mart.
 - Q So, you were back home about 12:30 or 1:00?
 - A Approximately there, yes.

- Q When you got there, did you notice whether or not your boys were home?
 - A. Yes, they were home.
 - Q. What were they doing?
 - A. Sleeping.
- Q. What did you do then the rest of the evening? Did you go to bed, too?
 - A. Yes, I went to bed.
- Q I will ask you whether or not either one of your boys ever left to your knowledge, ever left your trailer after you got home that night?
 - A. No.

MR. HEAD: No other questions. Thank you.

THE COURT: Cross examination?

MR. STEPHAN: No questions, Your Honor.

THE COURT: You may step down, sir. Thank you.

* * * * * *

WHEREUPON:

TED RITCHIE

the witness, having been duly sworn, was examined and testified as follows:

DIRECT EXAMINATION

- Q Young man, tell the Jury your name, please?
- A Ted Ritchie.
- Q Ted, how old are you?
- A Seventeen.
- Q. Where are you living right now?
- A Orlando, Florida.
- Q Back in February, were you living up in Dayton?
- A In Moraine.
- Q When did you come to Moraine?
- A In January.
- Q What was the reason for you coming here?
- A My brother's funeral.
- Q Were your folks up here at that time?
- A Yes, sir.
- Q When you were down in Florida, were you living with your folks then?
- A No. I was living with some friends of the family.
- Q Where were your folks living?
- A Gordon's Trailer Park on Kreitzer Road.

- Q Is that in Moraine?
- A Yes, sir.
- Q How long did you live with them up here?
- A About a month and a half.
- Q Did you move back to Florida?
- A Yes, sir.
- Q Did your folks move back at that same time?
- A Yes, sir.
- Q Did you know a fellow by the name of David Rowell?
- A No, sir.
- Q Do you remember the day that the body of a little boy was found in the field next to Gem City Trailer Court?
- A Yes, I remember.
- Q Let me take you back, if I can, to the night before, which would have been a Friday night. Okay? Do you know a girl by the name of Judy Tabor?
- A Yes.
- Q Were you over at Judy's house that night?
- A Yes, sir.
- Q Let's talk about -- Were you there more than one time that night?
- A Yes.
- Q When did you first go over there, do you remember?
- A It was about 8:00 o'clock.
- Q Who was all over there?
- A Judy and Alice Johnson and me and Mike went over there.

- Q Mike who?
- A Johnson.
- Q Is that Alice's brother?
- A Yes, sir.
- Q Was Alice more or less your girlfriend?
- A Well, I liked her, but we weren't --
- Q Hadn't gotten that far yet?
- A No.
- Q When you were over there, did you do any beer drinking?
- A Yes.
- Q And I will ask you did you smoke any marijuana over there?
- A Yes.
- Q We are just talking -- About how many people were there at that time?
- A Around five or six?
- A Were Jim and Joe Shipman there by that time?
- A Yes.
- Q Did they smoke marijuana, either one of them?
- A No.
- Q After Judy's -- How many beers did you have at Judy's trailer?
- A We drunk maybe about two apiece.
- Q And how many joints or manijuana cigarettes did you smoke?
- A Two or three.
- Q For all of you or just yourself?
- A For all of us.

- Q After Judy's trailer, did you go anywhere else?
- A Yes. We went to Darrell's, another guy named Darrell.
- Q Is that Darrell Doan?
- A Yes.
- Q What did you do over at Darrell's?
- A We drunk some more beer.
- Q What did you do after Darrell's?
- A Me, Mike and Jimmy's little brother, we took a walk.
- Q A walk where?
- A We stopped at Judy's and told his sister we were going to go to Keith's.
- Q Did you go over to Keith's?
- A Yes, sir.
- Q I will have you look around the courtroom, Teddy, and ask if you can see Keith anywhere here?
- A Over there (indicating).
- Q What is he wearing?
- A blue shirt, blue pants, and a pair of boots.

MR. HEAD: Indicating the Defendant for the record, Your Honor.

THE COURT: It may so indicate.

- Q About what time did you get to Keith's, do you remember?
- A It was 9:00 or 9:30.
- Q We are talking about four people, right?

- A Yes, sir.
- Q You and Mike?
- A And Jim and his brother.
- Q Did Keith let you in?
- A Yes.
- O Did he say anything to you when he opened the door as to who he thought you might have been?
- He said he thought it was somebody, but I don't remember what he said. He thought it was somebody else, but I don't remember what he said.
- Q . What did you do once you got inside?
- A Well, we watched some television. We sit down in the living room. We was listening to the stereo, and Mike asked him did he have some beer, and he gave us all a beer.
- Q Was Keith asked to supply anything else other than beer?
- A Yes, sir. Mike asked Keith did he have any liquor or pot.
- Q . What did Keith reply to that?
- He said that he had about a half a fifth of vodka left. He said he was going to save that for his party, but he said the rest of it, as I recall, he said him and David had drunk.
- Q Did he tell you David's last name?
- A No, sir.
- Q Did you know who he was referring to?
- A No, sir.
- Q Do you remember talking to the police shortly after David

Rowell's body was found in the field?

- A Yes, sir.
- Q Did the police ask you what went on in Keith's trailer?
- A Yes, sir.
- Q Did you tell them at that time what you just told us here today?
- I told them that he had said somebody, but I couldn't recall their name, but then the next day, you know, I was thinking about it because they told me if I remembered anything else to call them. Then I remembered that he said David, so I called them.
- Q Did you tell the police that?
- A Yes, sir.
- Q Do you recall what Keith was wearing that night?
- A Yes, sir.
- Q What was that?
- A He was wearing a hat, a pair of dark blue pants. I think they were corduroys, and a pair of cowboy boots. No shirt.
- Q I will show you what we have marked State's Exhibit No. 7 for identification. What are these?
- A Boots.
- Q Have you ever seen those boots before?
- A Yes, sir.
- Q Where?
- A He was wearing them that night.
- Q Had you known Keith before that night, Teddy?

- A No, sir.
- Q First night you had met him?
- A Yes, sir.
- Q Were you party to a conversation or did you overhear the Defendant and Mike Johnson talking about roughing up somebody?

MR. STEPHAN: Objection, Your Honor.

THE COURT: I am sorry?

MR. STEPHAN: It is hearsay. Objection. I don't think that this young man is of such an age that Mr. Head needs to lead him.

THE COURT: Would you read the guestion?

(Whereupon the previous question was read by the reporter.)

THE COURT: Well, the hearsay objection is overruled, but perhaps you can refrain from the leading questions. We will let this question stand.

BY MR. HEAD:

- Q Did you hear my question?
- A Yes, sir.
- Q Could you tell us about that conversation, Ted?
- Yes. Mike and Keith, they were sitting on the far end of the sofa, and Mike called Keith a queer and Keith said, you know, they stood up. He said, you want to go outside and fight about it? Then they dropped it somehow.

MR. STEPHAN: Could we have a conference?

THE COURT: Yes.

(Whereupon the following was had at the bench.)

MR. STEPHAN: If it please the Court, we move to strike the last series of questions and answers on several grounds. First of all, we renew our objection on the basis that Mr. Head asked a leading question. Secondly, we move to strike it on the basis it is not responsive. The question, as I recall it, was do you remember whether or not there was a conversation about roughing somebody up and his answer was, yes, Keith — or Mike called Keith a queer and they went out and had a fight. I don't think that is responsive. I stand on my objection that he was leading the witness with the question. We move to strike that portion of his testimony.

THE COURT: The Court is going to overrule the objection but does instruct counsel to refrain from leading the witness.

(Whereupon counsel returned to their respective tables.)

BY MR. HEAD:

- Q Ted, before the little conversation between Mike and Keith, did you hear Keith talk to Mike about anything else?
- A Yes, sir.
- Q What was that?
- He was telling Mike that he had to rough up someone for a hundred dollars, get some information out of him. Something to to do with Pit Bulls.
- Q After that, after he said that, did you hear the next little bit of conversation?
- No, sir. I was kind of like off and on listening to them, you

know.

Q What was the next thing you heard Keith and Mike talk about?

MR. STEPHAN: Your Honor, I am going to object to the form of the question.

THE COURT: Sustained.

MR. STEPHAN: Thank you.

BY MR. HEAD:

- Q After you said this about what you have already testified to -Well, strike that. I think we have gone over that. Do you
 remember you said you went to Jim -- Jim Shipman was there,
 right?
- A Yes, sir.
- Q Do you remember anything unusual happening with Jim Shipman?
- A Yes. He cut his hand on a beer can.
- O Do you remember what he did after he cut his hand?
- A No.
- Do you remember about what time or I will ask you this way. Did the Shipmans leave Keith's that night?
- Yes, sir.
- Do you remember about what time?
- It was about 10:40, 10:45.
- Were you intoxicated that night?
 - No, sir.
- Detween the time when you first started testifying about the time you were at Judy Tabor's all the way up to Keith's --

- A About 5:00 or 6:00.
- O How much marijuana had you smoked?
- A Myself or all of us?
- Q Yes.
- Q I'd smoked maybe about a half a joint.
- Q How long -- What did you do after the Shipmans left?
- A We stood around in the kitchen and we didn't talk about anything

 Just we were watching a little bit of television, listening

 to the stereo. We only stayed for about 15 minutes after they

 left.
- O Then what happened?
- A We left and went to Andy's.
- Q When you say we left, who is we?
- A Me and Mike Johnson.
- Q What kind of beer were you drinking at Keith's?
- A Old Milwaukee Lite.
- Ω Then you went to somebody's named Andy?
- A Yes, sir.
- Q Where was that, do you remember?
- It was over -- They call it the Dog Patch. It was behind the Civic Center. Then you go through the field and it is that firs street over there.
- Q How long did you stay over at Andy's?
- A About a half an hour.
- Q What did you do when you were over there?

- A We just talked mostly.
- Q Did you know this Andy fellow before?
- A No, sir.
- Q About how old is he?
- A Maybe about 14.
- O Did Mike Johnson know him?
- A Yes, sir.
- Q What did you do, if anything, after leaving Andy's?
- A We went to our trailer park, which was Gordon's, and we stopped at his cousin's, Judy, and she told me my mother was
- looking for me. I went on home and Mike stayed there.
- Q Just so we are clear about this. Gordon's Trailer Park, where is that in relation to Gem City Trailer Park?
- A The next one over to that one.
- Q So, you went home about what time?
- A About 15 to 12:00.
- Q. Did you -- What did you do when you got home?
- A Me and my mother went to Frisch's to get something to eat.
- Q Did you get something to eat at Frisch's?
- A Yes, sir.
- Q Where did you go after Frisch's, if anyplace?
- A We stopped at 7-Eleven.
- Q What was the purpose of that?
- A We got some cigarettes and some pop.
- Q What if anything did you do after stopping at 7-Eleven?

- A We went home.
- O About what time was this now?
- A It was about 1:15, 1:20.
- Q After you got home, what if anything did you do?
- A I went back up to Judy's to talk to Alice for a few minutes.
- Q Was Alice still there?
- A Yes, sir.
- Q Who else was there?
- A Judy, and Mike was on the floor asleep, covered up.
- Q Anybody else there?
- A No, sir.
- Q How long did you stay up there at Judy's?
- A Just about five minutes.
- Q What did you do after that?
- A Went home.
- Q Did you stay at home the rest of the evening?
- A No, sir.
- Q Was your mom home when you got home?
- A Yes, sir.
- Q Was she in bed or not?
- A No, she was still up.
- Q Do you recall about what time your mom went to bed?
- A Between 1:30 and quarter till 2:00.
- Q After she went to bed, what if anything did you do?
- A I went back up to Judy's, which is Mike's cousin.

- Q How long did you stay there?
- A I stayed there until about 3:30 or 4:00.
- Q It is in the morning now, right?
- A Yes.
- Q Who was all there, do you recall?
- A Me, Mike, Judy, Alice, Darrell, and Donnie.
- Q All right. What if anything happened at 3:30 or 4:00?
- A Me, Mike and Darrell left and we walked over to Darrell's house because Mike was going to spend the rest of the morning or evening with him, and I went on home.
- Q Were you supposed to be out that late?
- A No, sir.
- Q Did your mom know you were out?
- A No, sir.
- Q What did you do after you got to Darrell's?
- A I left.
- Q Where did you go?
- A Home.

MR. HEAD: One moment, Judge.

BY MR. HEAD:

- O Teddy, when you went back to Judy's after you got back from Frisch's and 7-Eleven --
- A Yes, sir.
- Q Who was all there?
- A Mike, Judy, and Alice, and when I got there I was there.

- O After you left and came back, who was all there?
- A Donnie, Darrell, and the rest of us I have already said.
- Ted, what kind of shoes were you wearing that night, do you recall?
- A No, sir.
- Q I will ask you whether or not you own a pair of cowboy boots?
- A I own a pair now. I just got them yesterday, though. I didn't at the time.
- O Do you recall when you went back to Judy's whether or not Mike Johnson had on any shoes?
- A He didn't have on any shoes.
- Q Were the shoes off, you mean?
- A Yes, they were off.
- Q Do you remember what kind of shoes they were?
- A Yes. They were something like snow boots, something like that.

 They had red shoe strings.
- Q I am sorry?
- A They had red shoe strings.
- Q Could you describe the toe of those snow shoes for us?
- They were round like this (indicating). On the bottom, they were like, you know, about this thick (indicating), like tracks, something like car tires off a car or something like that.

MR. HEAD: No other questions.

THE COURT: Cross examination?

MR. BOSTICK: Yes, Your Honor.

CROSS EXAMINATION

BY MR. BOSTICK:

- Q How old are you now?
- A Seventeen.
- O You attend school down in Florida?
- A Yes, sir.
- Q Beg pardon?
- A Yes, sir.
- Q What is your status; what grade?
- A Eleventh.
- Q Did you drop out of school when you came to Dayton?
- A Yes, momentarily.
- O For about two or three months, did you?
- A Yes.
- Q You had a death in your family about the first part of the year and that is why you came to Dayton?
- A. Yes, sir.
- Q You were here what, a couple months?
- A Yes, sir.
- Q Did you work during that time?
- A No.
- Q Did you attend school?
- A No.
- Q What did you do all day long and all night long?
- A Just hung around the trailer.

- Q Hung around the trailer?
- A Yes, sir.
- Q And engaged in some of the activities you told us about?
- A Not very often.
- Q You didn't drink often?
- A No.
- Q Didn't smoke often?
- A No.
- Q You had only met Keith Wampler one time?
- A That's right.
- Q And that is the night that you are telling us about?
- A Yes, sir.
- Q You indicated that you were not intoxicated that night?
- A No.
- Q Are you a light, medium, or heavy drinker?
- A I don't know. Medium, I guess.
- Q Medium?
- A Yes.
- Ω The beer and alcohol, if any, and the marijuana that you had on that Friday evening was that the most that you had ever had of drugs and intoxicants at one time?
- A I guess a few times I have had more.
- Q A few times you have had more?
- A I suppose, yes.
- Q You are the kind of young man who is not out of it if you have

had a beer or two?

- A No. If I drink them all at one time. We wasn't drinking all at one time. There was a span in between the beer we drunk, so --
- Q By the time that you had gotten to Keith's trailer you and the other fellows had at least a 12 pack, hadn't you?
- A Together?
- Q I am concerned about you.
- A Myself, did I have a 12 pack?
- Q You had been drinking from a 12 pack?
- A What do you mean? I don't understand.
- Q Well, let's back up a minute. By the time that you went to Keith's trailer, how many beers had you drunk?
- A About three.
- Q Incidentally, you didn't know Keith's trailer from any other trailer that night, did you?
- A Well, what do you mean?
- Q It wasn't your idea to go to Keith's trailer, was it?
- A No.
- Q Actually, you fellows were looking for more booze, weren't you?
- A I wasn't. Maybe Mike was.
- Q Well, you were with Mike, weren't you?
- A Yes.
- Q And you had been to Darrell's, had you?
- A Yes.

- Q And things got pretty boring because you ran out of beer there, didn't you?
- A No. We did not run out of beer over there.
- O Let me ask you this, young man. Had all the beer been drunk at Darrell's or hadn't it been?
- A No. All of it hadn't been.
- Q What you are saying is you could have stayed there at Darrell's or whoever else's house you were at and had more beer?
- A Yes.
- Q Why were you out walking around?
- A Because Mike told me he wanted me to meet one of his friends.
- Q Did he say who his friend was?
- A Yes, he said Keith, but I didn't know him.
- Q Go ahead.
- Q He said Keith, but I didn't know who he was.
- Q Did he say why he wanted you to meet Keith?
- A Yes.
- Q ' What did he tell you?
- A He said he might have, you know, some pot.
- Q He might have some pot?
- A Yes.
- You are sure that is what he said to you?
- A He might have -- I don't know exactly what he said, but I think that is what it was.
- You gave a statement to the Moraine Police Department?

- A Yes.
- Q The one that the prosecutor asked you about?
- A Yes.
- Do you remember giving this answer? Well, we were around, walking around the trailer court. It was boring and it was nothing to do. All the beer was gone. Everything. Mike said, let's go to my friend, Keith's house. I said, all right, you know. He said he might have some beer or something or his dad might not be home, you know. I said, all right. So, we walked over there. That's about it.
- A Yes.
- Q That was about it, wasn't it?
- A Yes.
- O The beer had run out, and your friend, Mike, said let's get more at Keith's. He may have some. His dad is probably not home. Wasn't that about it?
- A There was more over at Darrell's, but I didn't know that at the time.
- Q Would it be fair to say as far as you know that Keith didn't know you were coming, you and the other boys?
- A Yes.
- Q He wasn't expecting you?
- A No.
- Q When you knocked on the door and he came to the door and let you in and shortly thereafter you said that you thought he was
